### NZPPI'S EMA DEAL

Most members of NZPPI automatically become members of the Employers and Manufacturers Association (EMA) and can benefit from access to their services and advice at EMA member rates. There's no additional cost.

### SUBSCRIPTION FEES

#### Producers

0.3% of fee relevant turnover based upon a validated producer declaration for a member's most recently completed financial year prior to or at 31 March in each year. Relevant turnover is defined as gross income derived from the sale of plants produced in New Zealand inclusive of all charges, excluding royalties and GST, that a purchaser would pay.

Where a member supplies plants to another part of their business, fee relevant turnover is the wholesale value of gross income supported by an identifiable and discrete transfer value. If you need assistance with this, please speak with NZPPI's CEO.

Minimum fee \$350 plus GST.
