Annual Subscription Fees

NZPPI producer member subscription fees are calculated at 0.3% of relevant revenue from the sale of plants. This is equivalent to \$3/\$1000.

Relevant turnover is defined as gross income derived from the sale of plants produced in New Zealand inclusive of all charges (excluding royalties and GST) that a purchaser would pay.

The minimum subscription fee \$350+GST per year.

Please note: To protect confidentiality, membership fees are paid to an Independent Subscription Agent (ISA).

MARKET SECTORS

Each Producer member is asked to nominate which of the following broad market sectors account for the greatest portion of their turnover. This is used to establish a Producer's voting rights for the four sector-based Board members, and their ability to nominate someone for one of those sector-based Board positions. The broad market sectors are defined as:

- **Greenlife: Retail** Selling to retailers &/or direct to home gardeners.
- **Greenlife: Landscape** Selling to landscape and amenity businesses
- **Revegetation and Forestry** Selling to those involved in revegetation and forestry businesses and projects.
- **Horticulture and Viticulture** Selling to horticulture and/or vine growing businesses.

SUBSCRIPTION FEES

Producers

0.3% of relevant turnover based upon a validated producer declaration for a member's most recently completed financial year prior to or at 31 March in each year. Relevant turnover is defined as gross income derived from the sale of plants produced in New Zealand inclusive of all charges, excluding royalties and GST, that a purchaser would pay. Where a member supplies plants to another part of their business, relevant turnover is the wholesale value of gross income supported by an identifiable and discrete transfer value. Minimum fee \$350+GST.

Please note: To protect confidentiality, membership fees are paid to an Independent Subscription Agent (ISA). All fees are plus GST. Upon acceptance of your application we will send you a turnover declaration form for completion and sending on to the ISA complete with your payment or automatic payment form.
